# **Our Compliance Services**

### **Annual Inspections**

Annual inspections are required on active fall protection and suspended access systems to conform with relevant OSHA/ANSI standards as well as maintain current manufacturer warranties. Our annual inspections feature a review of the individual system components such as anchorages, which are inspected for structural deformities or deficiencies, issues with corrosion and weather coatings, signs of tampering with components or unauthorized modifications, or other deficiencies that could compromise the safety of the system and the workers who use it. We have inspection processes for PPE, hardware, non-certified anchorages, permanent systems, and more, to ensure that your systems and equipment are in good working order. (Cal/OSHA mandates bi-annual inspections in California.)

#### Recertification

Recertifications are to be performed at 5 or 10 year intervals depending on system type (10 years on suspended access/5 years on active fall protection) to comply with OSHA/ANSI standards. Our recertifications involve a visual inspection similar to that of an annual inspection, but also include onsite load testing to confirm proper capacity of anchorages, and further review of the system to confirm compliance with the latest codes and standards. This ensures that the system is in good working order and meets manufacturer requirements. Our certification tests will include documentation and a report produced by one of our fall protection engineers.

Our regular fall protection services ensure the continued compliance and proper function of your fall protection system, backed by our \$10M liability insurance.

By performing regular inspections and recertifications, we verify the system's compliance with safety and industry standards, as well as the original design and engineering specifications, provided it is used in accordance with manufacturer's instructions.

# **Mandated Training & Re-training**

Under OSHA, Cal/OSHA, and EM385 jurisdictions, employers are required to identify and train Authorized and Competent Persons for workers using fall protection equipment.


We offer 16-hour Competent Person, 8-hour Authorized User comprehensive, and 4-hour Authorized User essentials trainings. We can also train your team in their own work environment to avoid the disruption of sending them off site, allowing us to incorporate workplace scenarios where appropriate. We will maintain trainee records and can assist with re-training as necessary.

#### **Hazard Assessment**

A critical first step to preventing injury from falls is an analysis of the site to identify risks and how, why, when and where workers are exposed to hazards. We offer a complete on-site fall hazard assessment to determine whether your facility is in compliance with OSHA regulations or not. We will have a qualified person evaluate your site for all fall hazards, taking into consideration the many unique factors of each site. Based on our findings, we will provide a comprehensive report detailing all the potential fall hazards and our recommendations to meet or maintain regulatory standards at your site.
